Additional Requirements:

- All teams / participants must comply with field rules and prohibit use of Alcohol and Tobacco.
- Provide proof of general liability insurance (\$1M each occurrence) specifically naming the Village of Fox River Grove, the FRGRC and Fox River Grove School District #3 as additional insured (Attach).
- Rosters of participants with name and address to demonstrate resident requirements (Attach).
- All teams / participants must refrain from using infield and dirt areas if the field is closed due to weather (i.e. too muddy). FRGRC AD reserves the right to cancel / close fields due to weather or field conditions.
- All teams / participants must respect their scheduled times and end practice or game appropriately so the next scheduled may begin using the field at their scheduled time.
- Users' responsible for cleaning up litter and returning equipment as appropriate.
